**Website discussion**- developer was transferring everything over and did not get it all yet. Like the Facebook page and keep checking website. Website will be updated soon.

**NaloxBox discussion-** 2 free Naloxboxes are available to each county, Overdose Lifeline has reached out and asked about help finding locations in Cass County. The Naloxbox has 24-hour availability of Naloxene. May be able to ask Rick Baer, fire chief since the fire station is a neutral location and may feel safer than a police station. 9<sup>th</sup> and North Street could be an option- Rick Southwell could be contacted.

Ed- heat map shows mostly Logansport, may not be necessary for outer towns like Walton or Royal Center. Maybe Galveston?

Nikki- Walton library was a no, tried to email health department (no answer), tried Royal Center library (no answer), tried to contact a couple churches (no answers).

Chuck- could go in and talk to Logansport library.

Nikki- they usually do not allow anything there that doesn't pertain to their library in times past. Maybe a barrier could be stigma? Depending on location people may not feel safe enough to use it. What if someone steals the Naloxene? Will it be used by the average citizen or for emergency use? Dave- maybe get more information.

Chuck- would like a call with Amanda to talk about it more and maybe how Kiwanis could help. Naloxene is available for free, or at least it was.

Shift Happens is an online training and you can get as much as you want.

Overdose Lifeline should have for free and Pharmacies may still be free.

Maybe pharmacies could post a box outside? That could be an option.

Chuck- workbooks were bought for WRAP program.

**Rick-** passed around W.A.I.T. book for everyone to look at. Will be extending beyond the school year to offer camps throughout the summer also. Using LCC and United Way monies along with the YMCA to fund.
